Under this agreement SIM USA assumes responsibility for recruiting missionaries as well as the U.S. based care of those missionaries while Asian Access retains responsibility for championing the overall vision in Japan, managing the strategy of missionary deployment there and providing in-country missionary care. Asian Access and SIM USA will remain independent, each maintaining its distinct and separate ministry and board of directors.
